# LegalShield Advantage F.A.Q.

**Q. What if I am already subscribed to the Business Builder level of eService?**

A. Previous eService subscribers paying \$7.95/mo. Will be automatically grandfathered into LegalShield Advantage. However, they will not be able to participate in any of the recognition and incentives (listed on the previous page) unless they upgrade their payment to \$19.95 or \$20.95 per month.

**Q. What if I choose to not enroll in LegalShield Advantage?**

A. Associates who choose to not enroll in LegalShield Advantage will have basic access to the Associates Only Portal and LegalShield-specific LMS courses. Digital transactions will be made via the corporate site. While some limited recognition will be included for non-enrollees, it will not include corporate sponsored incentive programs (listed on the previous page).

**Q. If I am currently on the 60-day free trial for Business Builder, will I still have access to that free trial?**

A. Yes, you will get to finish your free trial period although you would not be eligible for incentives or promotions unless you have enrolled for LegalShield Advantage.

**Q. How do I enroll for LegalShield Advantage in my Associates Portal?**

A. You can enroll for LegalShield Advantage by accessing the Dashboard for your Associate Portal. Once you are in your Dashboard select "View Profile", from there you can select "My eService" you will then be able to select either Associate Portal or LegalShield Advantage eService.
